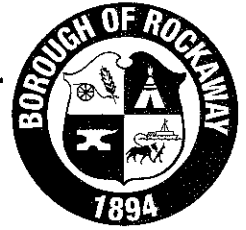

APPLICATION FOR WATER SERVICE

The undersigned hereby requests the Borough of Rockaway to supply water service to premises located on _____, known as Block _____, Lot _____, in the Borough of Rockaway, Rockaway Township or Denville, subject to regulations now or hereafter to be adopted concerning the supply and use of water service in the Borough, and further desires to rent from the Borough a meter of such design, type and size as said Borough may approve, authority being hereby given to have said meter installed at my/our expense for the purpose of measuring the supply of water applied for. I/We do hereby agree to pay therefore, without demand, the rates established by the Borough for water service.

Water main taps up to two inches will be made by the Borough. Water main taps over two inches will be the responsibility of the owner or the owner's contractor. All such taps shall be subject to inspection by the Borough. All excavation and backfilling are the responsibility of the owner or the owner's contractor.

You MUST attach the following:

- \$1,000 per connection for tapping fees for all taps to the municipal water system;
- A copy of your approved water allocation application and proof of payment in full;
- A connection fee of \$5 per gallon of usage per water allocation application;
- A certificate of insurance designating the specific project and guaranteeing notification to the Borough of Rockaway in the event of cancellation with the following coverages: comprehensive general liability policy at least \$1,000,000 each occurrence and \$2,000,000 general aggregate; workers compensation limits shall be \$1,000,000 each accident, \$1,000,000 disease-policy limit, \$1,000,000 disease - each employee; and commercial automobile policy limit shall be a minimum of \$1,000,000 each accident. All liability insurance shall include the Borough of Rockaway, its departments, agencies, boards, commissions, officers, officials, agents, servants, administrators, and employees as additional insureds, on a primary and non-contributory basis; AND
- Pursuant to Chapter 173, Licenses and Permits, if the applicant is the owner of the aforementioned property, the applicant must provide proof from the Borough of Rockaway Tax Collector that taxes and assessments have been paid through the current quarter for the aforementioned property prior to the issuance of this permit.
